2. Agents/professional handlers are only allowed to handle dogs that they own or co-own.
3. Wins carry no championship points.
4. Dogs must be in proper show clip. No taped ears are allowed in the ring. Spayed or neutered animals **MAY NOT** compete.
5. Dogs must **ALWAYS** be on a leash or be crated except when being judged.
6. Miscellaneous breeds can compete only up to the Best of Breed category.
7. Please keep the park clean so it will be available in the future. Dog scoops will be provided by CVDFFA.
