Dear Exhibitor,

Welcome to our 15th Annual Bark in the Park Dog Walk & Fun Fest! We are proud and excited to work with you on the largest pet event in Chesapeake!

The event will be held on Sunday, October 2, 2011, from 12pm to 5pm at Chesapeake City Park, 900 Greenbrier Parkway. Directions to the park can be found at chesapeakehumane.org. In the event we experience a weather event like last year, a rain date of October 16, 2011, has been reserved.

Booth spaces will be approximately 10x10. Each organization must provide its own tables, chairs, tents, etc. and all tents must be anchored. Organizations must be pet-related unless a sponsorship is purchased.

Organizations must arrive by 10:00am for unloading and setting up their booth space. All booths must be set up by 11:30am and organizations must not close their booth areas prior to the conclusion of the event at 5pm. Volunteers will be available to assist with setup and breakdown.

*We are once again hosting a fundraising dog walk in conjunction with the event and are asking for your help. As we did last year, we would like to reserve certain "perks" for our registered walkers as a reward for their fundraising efforts and encourage those who have not yet registered to do so the day of the event. **It would help us greatly if you could reserve a little "something special" exclusively for registered walkers** ... it doesn't need to be much – a discount for purchases, a no-cost raffle, etc. We are anticipating about 300 walkers, but will be able to provide a more accurate estimate by September 15th.*
